

Participant Waiver and Release of Liability Agreement

Please carefully read the following terms and conditions related to your participation in any CMI Candles (Continuing Memories In-Time) workshops and events. By registering and participating in any workshops and events you signify your acceptance of and obligation to these terms and conditions. If you have any objections to the following Agreement, you should not register for or attend any workshops or events.

Participant Conduct & Responsibilities:

CMI Candles (Continuing Memories In-Time) requires all participants to be respectful and professional to our staff, representatives, volunteers, other attendees and their guests or families throughout the event. CMI Candles (Continuing Memories In-Time) reserves the right to ask participants and/or their guests to leave the Facility immediately should they be deemed rude, uncooperative, unprofessional, intoxicated, or in possession of any illegal substance. In such a case, the participant's fees for the event will not be reimbursed under any circumstances.

Waiver and Release:

By registering for any event or workshop with CMI Candles (Continuing Memories In-Time) participants agree to release CMI Candles (Continuing Memories In-Time), its owners, building owners, representatives, employees, members, and volunteers (hereinafter, "Releasees") from all liability, claims, demands, and causes of action, of whatever kind of nature, either in law or equity, which may CMI Candles (Continuing Memories In-Time) hereafter arise from the use of or participation in any event at CMI Candles (Continuing Memories In-Time).
